3. Minimum qualification for admission

D. Pharm	Candidates passed in 2 nd PUC/intermediate/12 th standard or any other equivalent examination with science subjects.
B. Pharm	Candidates passed in 2 nd PUC/intermediate/12 th standard or any other equivalent examination with minimum 40% marks in any combination comprising of PCM or PCB or candidates who have scored less than 40% marks in 10+2 but completed D. Pharm course are eligible to 2 nd B. Pharm directly. Candidates passed 10+2 standard from any foreign university and after taking eligibility certificate from Rajiv Gandhi University of Health Sciences, Karnataka.
M. Pharm	Candidates passed B. Pharm of any recognized Indian university with not less than 55% marks aggregate marks. Candidates passed B. Pharm from any foreign university and after taking eligibility certificate from Rajiv Gandhi University of Health Sciences, Karnataka.
Pharm D.	Candidates passed in 2 nd PUC/intermediate/12 th standard or any other equivalent examination with minimum 40% marks in any combination comprising of PCM or PCB. Candidates passed 10+2 standard from any foreign university and after taking eligibility certificate from Rajiv Gandhi University of Health Sciences, Karnataka.
